

VISA

CITIZENS OF THE EU/ EEA MEMBER STATES

Citizens of EU/EEA (EEA: member states of the EU and Norway, Switzerland, Iceland, and Lichtenstein) may travel to Hungary without a long-term study visa. However they need to obtain a registration card for the duration of the studies in Hungary.

CITIZENS OF COUNTRIES OUTSIDE THE EEA

If a student is from the non-European Economic Area (non-EEA), he/she needs to apply for a long-term "D" type visa for study purposes at the Hungarian Consulate of his/her country of residence. Please note that this type of visa is a special national single entry visa that enables its holder to apply for a residence permit for study purposes after enrolling in a university in Hungary. This visa, contrary to the Schengen (tourist) visa, can only be obtained from the Hungarian consulates listed here.

If the student requires a visa, please ask for a visa appointment as soon as possible (right after the student is notified about your acceptance), because in some cases the process can take up to three months, or even longer for visa applications with missing information.

The following documents are needed for the application for residence permit:

- 1. a wholly and legibly completed, signed "residence permit" application form.
- 2. valid passport (the validity of which has to exceed that of the requested visa by at least 3 months)
- 3. one passport size photos (not older than 3 months)
- 4. confirmation of Acceptance from the University of Pécs (Letter of Admission)
- 5. visa fee: ~60 EUR
- 6. declaring a real, exact address in Hungary (the document certifying accommodation in a student hostel or the tenancy contract)
- 7. documents certifying subsistence in Hungary (bank account statement; or the declaration of the parents that they assume coverage of all costs of the stay in Hungary; or the document certifying the scholarship)
- 8. attestation of the school that the applicant is exempt from the payment of school fees or that he/she has already paid the tuition fees.
- 9. travel insurance (A travel insurance is required to cover medical expenses, trip cancellation, lost luggage, flight accidents and other losses incurred while traveling; it can usually be arranged at the time of the booking of a trip and should be valid until the beginning of the study program) or equal financial means

After you arrive in Pécs, you can arrange your registration card (EEA) or residence permit (non-EEA) at the Immigration and Asylum Office (in Hungarian: Bevándorlási és Menekültügyi Hivatal, abbreviated as BMH).

REGISTRATION CARD AND RESIDENCE PERMIT

A residence permit may be issued on grounds of pursuit of studies to third-country nationals accepted by an establishment of secondary or higher education accredited in the Republic of Hungary and admitted to the territory of the Republic of Hungary to pursue as his/her main activity a full-time course of study, or to attend a course in an establishment of higher education, which may cover a preparatory course prior to such education.

INFORMATION FOR STUDENTS ABOUT APPLYING FOR REGISTRATION CARD OF STUDY REASON

For EU, EEA or Swiss citizens

- 1. You have to bring your valid passport or ID when you go to the Immigration Office.
- 2. You have to pay the issuance fee of a 1.000,- Ft at the Immigration Office by card or you have to certify that you paid in the fee on a postal cheque.
- 3. You have to totally fill out and take the "application form of registration card for study reason" with you when you go to the Immigration Office latest on 93. day after you entered Hungary.
- 4. You have to attach the acceptance letter (in the summer when you will be a first semester student) or active student status certification (when you have already started the school before) from the school with the correct form.
- 5. You have to certify an address in the local Immigration Office's competence:
 - you are the owner: you may declare about this fact in the application form point 36.
 - you are a tenant/subtenant: the valid rental contract or agreement about the flat (every owner must agree with the fact that you live in the flat all of them must be in the contract or they have to agree with the contract in a declaration).
 - The contract/agreement must be dated, signed by the lessors and tenants, contained the most important information (correct, official address termination, rental fee, etc.).
 - if you live in dormitory attach the correct dormitory certification that is signed and stamped by the house-manager

6. You have to certify

- valid health insurance in Hungary (European health insurance card is also acceptable) or
- you have to make a declaration about separated money amount for covering the costs of any health treatment in Hungary in the application form point 41., and certify the available savings.
- 7. You will be asked to make a declaration about your appropriate source for Hungarian stay in front of the colleagues of Immigration Office.

Documents have to be seen and sometimes taken in original so please have the original ones with you. Applications, forms must be filled out totally and correctly according to the data of your passport or ID.

If you have not changed your address from the last permission and the attached rental contract is still valid you can declare this fact and that the circumstances are still the same. If you still live in the same place but the contract is not valid anymore have a new valid contract.

Documents have to be seen and sometimes taken in original so please have the original ones with you.

You must **be careful with the deadlines**. Even if you do not have every document it is possible to start the procedure because you will get a list about the missing documents. Please keep the receipts and missing lists and if later you take the missing documents with you please show these lists as well to our colleagues – this helps to follow how your case is going on.

Applications, forms must be filled out totally and correctly according to the data of your passport.

In case of having the 30 day – D type visa (that was issued in a Hungarian embassy and valid for taking the residence permit) please go to the Immigration Office with your passport, one photo (stamped by the embassy) and the official accommodation paper that is signed by the owner/s.

Don't **forget to write your name on your mailbox** in order to receive the official letters sent by any office to you.
