Call for Applications for Students in PhD Programme

The University of Pécs Faculty of Pharmacy calls for applications for participating in the Erasmus+ Short-term doctoral mobility in the Academic Year 2023/2024

The aim of the call for applications:

is to enable research, educational, linguistic and cultural experiences in a higher education institution in another country. Mobility should facilitate the student's academic/research career and personal development.

Erasmus+ students who are successful in their application will have the opportunity to take part in a mobility programme to one of our partner universities in the European Union. The aim of mobility is to research and to support the preparation of a dissertation. Mobility can only take place if the mobility abroad is accepted by the sending institution. The possible duration of short-term mobility abroad is between 5 and 30 days.

The mobility must take place between: 01.03.2024- 19.07.2024

Currency of the mobility: **HUF**

Students studying abroad under the Erasmus+ programme:

- spend 5-30 days abroad;
- enrol at home, establish active student status, pay any tuition fees at the home university and receive their regular scholarship for the duration of their stay abroad;
- by being mobile abroad, they replace part of their study obligations at home (the sending and host parties agree, before the student leaves, on the student's research work will be carried out at the receiving university);
- PhD students can also carry out research at the partner university as part of their training plan;
- conference attendance is not eligible

Who can apply?

General conditions for participation:

- the student is a Hungarian citizen or a PhD student of another nationality; the student is a Hungarian citizen or a student of another nationality participating in a PhD program of the institute
- departure is possible after the first completed semester of postgraduate studies at the earliest
- be an active student at UPMS/FP in the semester in which the mobility takes place; the PhD degree cannot be obtained before the end of the mobility period
- meet the application requirements announced by the faculties.

Documents to be submitted by the applicants:

- 1. Motivation Letter (approximately 1500 characters)
- 2. Professional CV
- 3. Supervisor's recommendation
- 4. Language certificate

- 5. Transcript of records
- 6. Documents certifying activities in public life and/or research
- 7. Official invitation letter from the institution
- 8. Copy of diploma
- 9. List of publications

According to Erasmus+ rules, each student can be granted Erasmus status for a maximum of 12 months per level (total of part-time studies and traineeship), so if the applicant has previously participated in an Erasmus part-time study and/or traineeship at their current level even if they were an unsubsidised (LABEL) student - but did not use the 12-month Erasmus period, they can reapply. Doctoral students who have already been Erasmus students in the previous stage(s) of their training may also apply.

Grants for the academic year 2023/2024

The amount of the grant depends on the length of the period of traineeship (number of days) and on the host country. The following amounts of the grant may presumably be awarded for the academic year 2023/2024.

Duration of physical activity	Amount of scholarship grant	
By day 5-14 of the activity	28.000 HUF/DAY	
Between 15 and 30 days of activity	20.000 HUF/DAY	

FORINT-BASED SHOLARSHIP PAYMENT

One day of travel before the activity and one day of travel after the activity can be covered by the individual grant.

Students with fewer opportunities are entitled to a supplementary grant of 40.000 HUF for 5-30 days of physical mobility in addition to their individual grant under the EU Erasmus+programme. Equal opportunities support is granted on the basis of a separate application.

Travel allowance:

Students who choose green/environmentally friendly travel will receive a one-off contribution of 20.000 HUF in addition to their individual allowance and, where applicable, an additional individual allowance of up to 2 days to cover the travel days associated with return travel.

Please note that the scholarship does not cover all the costs incurred during your stay abroad and will need to be supplemented from other sources.

Method and deadline for submitting the application:

Applications are accepted continuously throughout the academic year, but the application deadline is 1-1,5 months before departure, at latest until 14 June, 2024 on the Mobility Online interface.

In line with Faculty regulations, applications can be submitted online at <u>Application surface for</u> short-term mobilities

Applications that are incomplete, do not satisfy the conditions, are illegible or submitted after the expiry of the deadline cannot be accepted.

IMPORTANT: getting an Erasmus status does not automatically mean the transfer of the scholarship. To be eligible for participating in the mobility, the student must:

- manage the residence permit and visa (in the receiving country) on her/his own,
- have a fully signed Learning Agreement for Traineeship, support agreement, liability and accident insurance.

The evaluation will be continuous throughout the academic year and will be based on the assessment of the professional plan. In addition to the importance of the professional work plan, the applicant's performance will be scored according to the points system. If the applicant does not achieve the minimum 5 points, his/her application will not be accepted.
