Quality objectives of the University of Pécs for the 2021/2022 academic year

In accordance with the quality assurance regulation of the University of Pécs approved at a Senate in February 2018, the quality objectives of the university are defined for each year by the Rector. The meeting of the objectives must be checked and documented. On the ground of the professional recommendation of the Quality Development Committee, *I hereby define the quality objectives for the 2021/2022 academic year*.

Quality objective 1: Elaboration and introduction of the university performance evaluation system in line with the change of model

Background of the setting of the quality objective:

As a result of the process of the 'change of model' implemented in 2021, the performance-based component will have an increasing role in the financing of the activity of the University in the coming five years. Similarly, at the level of individuals a much more direct connection will be seen between measured and documented performance, and wages. This makes it indispensable to establish a new Performance Evaluation System (PES) which is capable of measuring performances of the faculties in a comparable way, built on full-university standards but also taking the specialities of the respective faculties into consideration.

Specification of the quality objective:

Until the end of the 2021/2022 academic year, a new Performance Evaluation System (PES), which is in line with the change of model, valid for the whole university but also effectively integrating the specialities of the respective faculties, shall be elaborated, and introduced at each faculty.

Quality objective 2: Increase of quality of incoming students at selected areas

Background of the setting of the quality objective:

The change of model and the new frameworks of financing coming from this will place an emphasis greater than before on the expectations concerning the decrease of student dropout. This is targeted primarily on the selected areas (medical training, business and economics, informatics, technical sciences, teacher training). One tool for the decrease of subsequent dropout rates can be the increase of quality of incoming students. Decreased dropout rates can also have a positive impact on students' learning experience and student satisfaction.

Specification of the quality objective:

In the general admission procedure of 2022 (2022G), the average points of students admitted to full-time bachelor programmes and undivided programmes should increase in at least three selected areas in comparison with the admission procedure of the year before.
